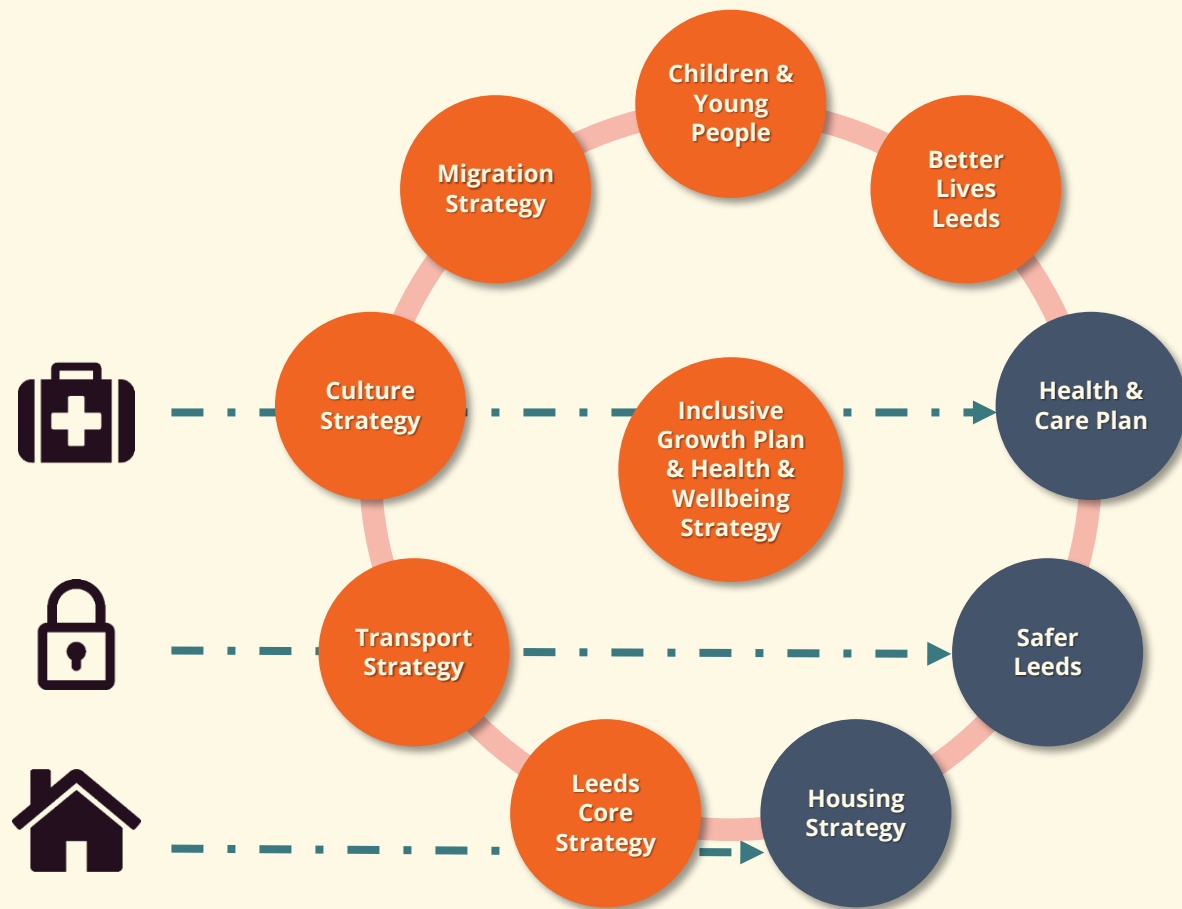

How LMP priorities map on to the various strategies for Leeds



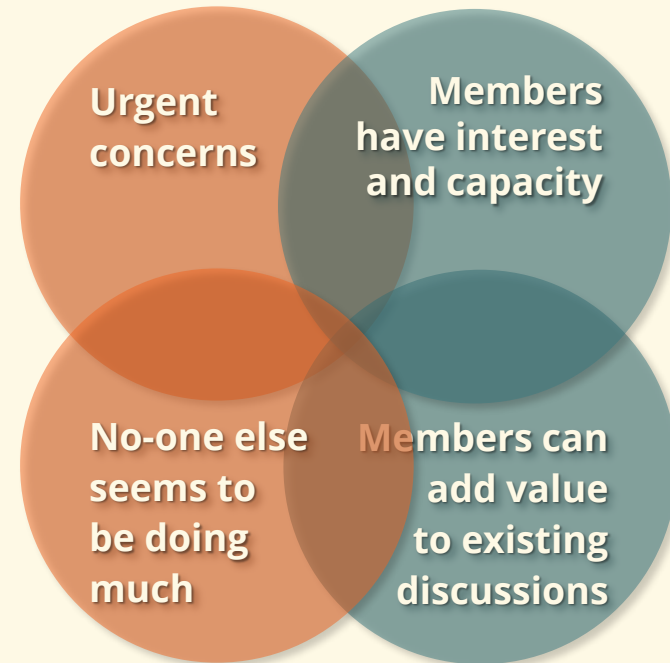
How we agreed our Priorities last time

Housing



To end destitution among migrants in Leeds

- Soliciting support from NACCOM for NRPF
- Joining Leeds Homeless Forum
- Ensuring migrant voices are heard at a senior strategic level

Appropriate accommodation is available when migrants need it

- Cross sector working on 28 day transition period
- Influencing APPG on transition period
