➤ The Leeds Approach to Think Family, Work Family; Principles and Practice Guidance

Think Family – all staff need to remember that people often do not live in complete isolation and therefore we need to understand the needs of the wider family when we are working with a child, parent or adult.

Work Family – all staff and services need to work together to make sure that that people working with children, young people and adults in a family, plan and coordinate their work.

Think Family, Work Family – is an approach which helps to understand the unique circumstances of an adult or child, and the strengths and resources within the family to provide for their needs. It places a responsibility on all practitioners to respond to identified issues from signposting and referral, through to providing services. Click [here](#) for this document.
